- Providing history of how the Family First Center idea came to be, Mayor Law and Doug Baldwin,
- Healthpoint as a partner, will run facilities.
- Partnering with school district who is leasing the land to the foundation
- STEM programming included
- Project is ready to bid late this year, awarding bid early spring to start project soon after.
